Problem Statement

- Crypto trading and sniping present challenges such as volatility, liquidity risks, fraud, scams, and security concerns, often complicating timely trade execution especially across multiple blockchains and assets.

- DeadShot addresses these challenges by offering a comprehensive suite of features designed to empower traders. From high-speed transactions to advanced analysis tools and anti-scam detection, this bot empowers traders to take control of their crypto investments while minimizing risks.

- Supports Multi-Chain

- Copies and multiplies gas for front-running.
- Snipes V2 and V3 Liquidity
- Snipes the exact amount of tokens defined.
- Snipes through encrypted smart contracts to prevent sandwich bots, copy bots, and front-runners.
- Anti-rug and Anti-blacklisting
- Supports EIP-1559 (ETH)
- Sophisticated filter against bad actors.
- Classic Sniping
- Executes Rapidly

Why HODL \$LYNX?

Token Utility

Our native token, \$LYNX, powers the ecosystem. Users need to hold at least 1,000 \$LYNX to unlock top-tier features and experience the full range of ecosystem benefits.









Multiple Reward Structure (MRS)

- Rewards will be generated from the following sources:
 - a. 1% transaction tax for the Sniping bot.
 - b. 5% \$LYNX Buy and Sell Tax
 - c. Staking reward pool of 500,000 \$LYNX.
- **Tiered Rewards Program:** Qualify for tier rewards with a minimum 35-day holding period.
 - Tier 1: Holders with **≥ 50,000 \$LYNX** share **60%** of DeadShot's tax revenue pool and **6%** of the monthly tax trading volume pool from \$LYNX transactions.
 - Tier 2: Holders with **1,000 to 49,999.99 \$LYNX** share **40%** of DeadShot's tax revenue pool and **4%** of the monthly tax trading volume pool.
- **HODLer Rewards:** No minimum holding period. Receive **30%** of the Gross Tax Revenue, redistributed to existing holders to **incentivize holding (24%)** and **liquidity provision (6%)**.
- **Staking:** Stake \$LYNX for up to a **17.99% APR** to grow your crypto portfolio and generate passive income.

TBV = Total Bot Volume **\$1,552,000**

LGTR = LYNX Gross Tax Revenue (5% Total Buy/Sell Token Volume)

DGTR = DeadShot Gross Tax Revenue (1% of TBV)

\$15,520 DGTR * 70% / 20 Holders = \$543 Per Month (ETH)

\$600,000 LGTR * 7% / 20 Holders = \$2,100 Per Month (ETH)

50,000 \$LYNX * 17.99% APR = 749.58 \$LYNX Per Month (LYNX)

\$600,000 LGTR * 24% Reflection Reward = \$1,440 Per Month (ETH)

Assumption: 20 Qualified Holders, \$600,000 Token revenue, Sniping Bot Vol \$1,552,000
Anti-Whale = Max of 1.5% per Wallet

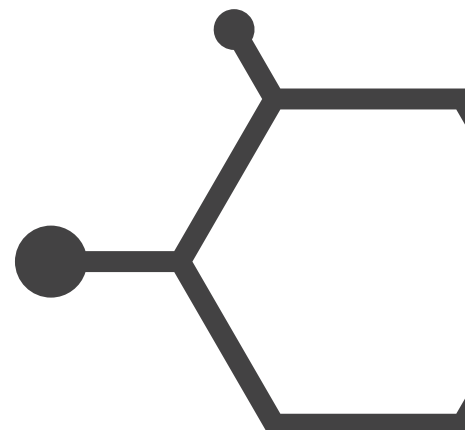
- Regular security audits proactively verify and maintain the trustworthiness of our products, identifying and addressing vulnerabilities to enhance system integrity against potential threats.

- User responsibility is paramount. You must securely manage and protect your private keys, phrases, and sensitive information. DeadShot Bot cannot retrieve lost or compromised data.





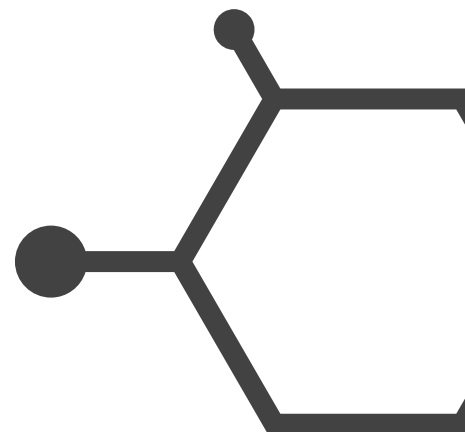
